



## 2024 FEES SCHEDULE

The annual fee covers the costs of tuition, excursions and compulsory camps and retreats. Reductions in fees will be made where:

- Families hold a Health Care Card (HCC) and are eligible for assistance under the Victorian Governments' Camps, Sports and Excursions Fund (CSEF) program.
- Siblings are attending the College at the same time.
- Payment in full is received by 23 February 2024.

**Assistance for Health Care Card (HCC) holders** – As camps, retreats and excursions are included in our fees, the \$250 provided by the State under its CSEF program will be allocated to tuition accounts. As families who meet the CSEF criteria also attract additional grant support, a further \$1,000 reduction (per student) will be applied, providing a scheduled payment arrangement is agreed with the College. In Instances where both parents hold a HCC the assistance shall be split.

**Sibling discounts** - The annual tuition fee will be reduced by 10% for a sibling and 50% for a 2nd sibling attending MSJ in 2024. This discount does not apply to extra-curricular activities such as VCE VM etc.

**Additional program fees** – Extra-curricular activities that are available at additional cost include VCE VM (external courses), music, interstate / overseas trips. These programs are only available to students where annual fees have been or are being settled in accordance with an approved payment option listed in the above schedule.

**Payment methods** - The College accepts BPay, cash, credit / debit card (Visa & Mastercard only), direct debit and Centrepay authorities.

**Pro rata fees** - shall apply in instances where a student commences / departs during an academic year.

***Please note** that fees must be finalised by 23 September 2024. Statements will be issued during 2024 so that families can monitor their account. If difficulties are experienced, families should contact the College in writing and include a proposal for settlement of the account. Any alternative arrangement would apply for 2024 only.*
